DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Follow all applicable directions, restrictions, and precautions including statements pertaining to the Worker Protection Standards, on the EPA-registered Fusilade DX Herbicide label.

This label must be in the possession of the user at the time of application.

FINE FESCUE (Grown for Seed): For control of quackgrass (*Agropyron repens*) in fine fescue grown for seed in Minnesota, make two applications of FUSILADE DX Herbicide following the application directions on the EPA-registered label.

WEED	APPLICATION	HEIGHT (IN.)	RATE (PINTS/A)
Quackgrass	1st	6 to 10	0.75 to 1
	2nd	up to 10	0.75 to 1

Make the second application 2 to 3 weeks after the first, but before the quackgrass exceeds 10 inches in height. Do not make a second application if excessive injury occurs after the first application. Always use crop oil concentrate at 1% v/v in the spray solution.

RESTRICTIONS

- (1) For use only on fields of fine fescue (chewings, creeping red, and hard fescues) grown for seed. Other types of fescue may not be tolerant.
- (2) Do not apply after boot stage of fescue.
- (3) Not for use on fields producing fine fescue for livestock feed. No portion of the treated field, including seed, seed screenings, hay, forage or stubble, may be used for human or animal feed.
- (4) Producers of Fine Fescue Seed who use FUSILADE DX Herbicide, or cause the product to be used on fields they operate, are required to inform, in writing, conditioners receiving seed produced on treated fields of the product's use. A copy of this labeling is required to be provided to the conditioner by the producer.
- (5) Use of FUSILADE DX Herbicide according to this labeling is deemed a non-food use.
- (6) All Fine Fescue Seed from fields treated with FUSILADE DX Herbicide is to be tagged at the Conditioning Plant, "Not for human or animal consumption."

Do not apply this product through any type of irrigation system.
