Product: **Fusilade[®] DX Herbicide (EPA Reg. No. 100-1070) in a tank mix with Touchdown[®] Herbicide (EPA Reg. No. 100-1117), Touchdown Total[™] Herbicide (EPA Reg. No. 100-1169), Touchdown Hi-Tech[™] Herbicide (EPA Reg. No. 100-1182) or other glyphosate formulations registered for Roundup Ready[®] soybeans and cotton.**

Use: Fusilade DX tank mix with glyphosate products for control of volunteer Roundup Ready corn in Roundup Ready soybeans and cotton.

States: Alabama, Arkansas, Delaware, Florida, Georgia, Illinois, Iowa, Louisiana, Kansas, Kentucky, Maryland, Michigan, Minnesota, Mississippi, Missouri, Nebraska, New Jersey, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, Tennessee, South Carolina, South Dakota, Virginia, Wisconsin

DIRECTIONS FOR USE

Tank mix Fusilade DX plus one of the glyphosate products indicated above for control of volunteer Roundup Ready corn in Roundup Ready soybeans and cotton. Refer to the table below for recommended rates.

Weed	Fusilade DX Rate	Glyphosate Rate
Roundup Ready volunteer corn	4 - 6 oz./A ¹	Follow recommended label rate

¹ Use the 4 oz/A rate only under the following conditions:

- Application under favorable soil moisture and humidity conditions which normally occurs within a few days after rainfall or irrigation. Avoid extreme air temperatures.
- Application when volunteer corn is less than 12 inches tall.
- Application with 0.25% v/v crop oil concentrate (COC). This COC is in addition to the additives required by the glyphosate product.

If the above conditions do not exist use the higher rate.

RESTRICTIONS:

POSTEMERGENCE APPLICATION OF THIS TANK MIX ON SOYBEAN OR COTTON VARIETIES WHICH DO NOT CONTAIN THE ROUNDUP READY GENE WILL RESULT IN SEVERE CROP INJURY OR PLANT DEATH.

The most restrictive labeling for any individual product applies for tank mixing.

Do not allow this tank mix to be applied or to move off target as contact by even minute quantities can cause severe damage or death to any non-target vegetation.

The user must refer to the federally approved Fusilade DX, Touchdown, Touchdown Total, Touchdown Hi-Tech (or other glyphosate formulations registered for Roundup Ready soybean or cotton) labels and read and follow all applicable directions for use, restrictions, and precautions.

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

This recommendation should be in the possession of the user at the time of pesticide application.
